



## Adult Participant Waiver - RELEASE OF LIABILITY & COVENANT NOT TO SUE

In consideration of being allowed to participate in Bubble Football) I, the undersigned, acknowledge, covenant and agree that: There is a potential risk of injury and/or death from the activities involved in the participation, including, but not limited to the following

i) sprains; (ii) strains; (iii) broken bones; (iv) fractures; (v) cuts and bruises; (vi) heart attack and (vii) the potential for permanent paralysis and/or death

I am aware of the risks involved and I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF Bubble Football Gibraltar or others, and assume full responsibility for my participation

I, for myself and on behalf of my heirs, assigns, personal representatives and/or next of kin, forever WAIVE, RELEASE, DISCHARGE and COVENANT NOT TO SUE Mr Ian Hancock or any employees of the company trading as Bubble Football Gibraltar, WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, and/or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF Bubble Football Gibraltar OR OTHERWISE. I further agree to indemnify, defend and hold harmless from any loss, liability, cost, claim for damages arising from my participation in Bubble Football

I attest and verify that I am free from all illnesses, injuries and defects and that I am physically and mentally fit and sufficiently trained to participate in all activities associated with Bubble Football. My participation in Bubble Football is entirely voluntary

I will operate all equipment used in Bubble Football in a safe and reasonable manner and I take full responsibility for any injury or damage which I may inflict on another person or their property as a result of my participation. I will NOT kick, punch, throw, jump on or use the Bubble Footballs in any way other than instructed. I understand that should the Bubble Football become damaged from my misuse I will be liable to pay the cost of a replacement Bubble Football approximately £300

I am over 18 years of age and I understand that this document constitutes a release of liability and a waiver of my legal rights, I have read and fully understand the document and I sign it freely and voluntarily without any inducement
